#### BECOME PART OF 65 YEARS OF HERITAGE

The Master Locksmiths Association was first conceived in 1957 and was the idea of the Chubb Lock Company, and one or two London locksmiths. The prime mover was Mr Steve Fallshaw, then a locksmith in the Barbican, who became its first Chairman when it was formally founded early in 1958.

The original 16 members decided the new 'association' should be known as The Greater London Master Locksmiths Association (GLMLA). By the end of the first decade it had grown nationally with a wide distribution of members from all parts of the UK. At this time, it elected its first national President, namely Mr Steve Stephens of Oxford. The association by now included members from overseas and a healthy growth has been maintained, we now number almost 1500 members in all sectors.

In the early '90s the association restructured to meet modern demands, retaining its title Master Locksmiths Association (MLA) it formed three main sectors: Personal Membership (for individual members wanting personal accreditation), Approved Company Membership (for trading locksmith companies meeting the high criteria stipulated by the association), and Affiliate Members (suppliers to the locksmith industry)

## CHAMPIONING THE FUTURE OF LOCKSMITHING

In September 2021 we, supported by Mark Pawsley our local Conservative MP, called for government licensing of the locksmith industry following hundreds of reports from householders who had fallen victim to the unscrupulous activities of those masquerading as locksmiths. The government deemed additional licensing unnecessary due to the Master Locksmiths Association's existing accreditation scheme, which effectively vets, inspects, and qualifies approved locksmiths.

We will continue to raise awareness on this issue and recently appeared in the BBCs Rogue Traders programme as well as Sky News, where we turned focus onto search engines allowing false advertisements.

#### **Approved Company**

#### APPROVED COMPANY MEMBERSHIP

Aimed at your company rather than you as an individual, for members who are self employed and have their own business; you could be a sole trader or a larger company with employees.

All approved companies must have at least one Qualified Master Locksmith in their employment, which means many of our Approved Company owners also have a personal membership.

### **Approved Company**

This category is for companies and locksmiths trading in their own right, with retail premises or operating as a mobile locksmithing business. Trading directly with the public and private sectors, the Approved Companies inspectorate means the MLA can demonstrate that all company members are meeting high standards.

Each company is inspected on a regular basis, thus ensuring that members and their operatives maintain standards in workmanship and administration. Also, members are expected to conform to legal requirements and work to our customer charters of customer service satisfaction. Inspections have the effect of making locksmithing companies more accountable for their daily operations.

### **Approved Company**

#### Requirements

- MLA Approved Company members must have a fully paid up Qualified Master Locksmiths (QML) member in place.
- For Approved Companies who employ more than 5 locksmiths, 20% of them will need to be paid up QML members (i.e. personal members who've taken and passed the MLA Exam). This therefore means that Approved Companies with 6-10 employed locksmiths will need 2 QML members, those with 11-15 locksmiths will need 3 QML members etc.
- If you do not have a QML member, or don't have sufficient QML members based on the number of Locksmiths employed, then you will need to apply for Personal Membership first and progress your membership to Approved Company once you, or a member of your staff has passed the MLA exam.
- All Approved Companies must have an on site inspection. We'll send you more information on this once your inspection is booked.

#### **Approved Company Membership Costs**

Standard DBS check: £31\*

Enrolment Fee: £146.40 (if applicant is already a member this will be waived)

Annual Membership Subscription Fee: (MAIN) £486.00, (BRANCH) £486.00

First Inspection fee: £305.40 (MAIN), (SAME DAY BRANCH) £99.75

The reduced rate of £99.75 will apply to branch inspections carried out after the main branch on the same day. Any branch inspection carried our on a different day will cost £305.40

Unless under exceptional circumstances, regular inspections after the first are included in your subscription fees.

Quarterly payment options are available for membership subscription fees

\*If you already have had a DBS issued within the last 3 years you may use this - simply email a copy to membership@locksmiths.co.uk

### **Application Process**

Each membership application is submitted to the membership for any objections and must be approved by our board of directors.

- Submit your application form and photo of applicant and locksmith employees to Audra Petherick membership@locksmiths.co.uk.
- We'll check your application and let you know the next steps.
- A temporary membership number will be provided to you and your staff to use for discounted training rates.
- We'll invoice you for your enrolment and standard DBS fees if required\*.
- Your application will be published in our Keyways magazine or our e-newsletter.

Applications will need 21 days from the date of Keyways Magazine / e-newsletter distribution for members approval

- 6 Your application will be reviewed by the Board of Directors
- Once approved we'll ask you for your inspection fee payment
- Upon receipt of payment we'll arrange your company inspection
- After passing the inspection, you'll receive a welcome pack containing a membership number, ID card, and certificate for the applicant and staff members.

#### \*ENROLEMENT FEE

All new applicants are required to forward a non-refundable enrolment fee of £139.75 (incl. VAT). This fee is waived for existing members.

#### STANDARD DBS

A standard Disclosure from the Disclosure & Baring Service check is required on the company owner(s)/director(s) and all locksmiths. For Approved Companies this needs to be performed on the company owner/director and all locksmiths. The cost of this is £31 per person (which should be included with your application).

## Application FAQs

#### Q. What is involved?

**A.** Further guidelines and advice can be found on the following pages.

- 1. The application form needs to be completed by existing personal members and new applicants. ALL NEW APPLICANTS ARE REQUIRED TO FORWARD A NON-RETURNABLE ENROLMENT FEE OF £146.40 (inc VAT) WITH THESE FORMS (this fee is waived for existing members). (Please see Q/A regarding Disclosure Barring Service Check [DBS]).
- 2. The application forms and DBS check are submitted to MLA Head Office, checked by staff and then processed, and an acknowledgement letter will be issued and examination confirmation, where necessary.
- 3.Once the DBS check has been completed and your locksmith has passed the examination to become a Qualified Master Locksmith, an invoice for the inspection fee (see below) will be issued.
- 4. Following payment of the inspection fee, arrangements will be made for an experienced member of our inspectorate to carry out the inspection which may also include a site inspection.
- 5. After the inspection, the Inspector will submit his recommendations to the Directors for their final decision.
- 6. Notification of your application will be published in Keyways, giving the membership 21 days to lodge any objection.

#### Q. Is a Disclosure & Baring Service Check necessary?

**A.** Yes due to the important nature of ethics within the MLA, we insist on checking the criminal records of our members and therefore a Standard Disclosure from the Disclosure & Baring Service check is required on the company owner(s)/director(s) and all locksmiths. For Approved Companies this needs to be performed on the company owner/director and all locksmith staff. The cost of this is £31 per person (which should be included with your application).

#### Q. How much does an inspection cost?

A. Sole or main premises £305.40

Branch premises if able to be inspected on same day as main premises £99.75
Branch premises if inspected on another day £305.40
Regular re-inspection costs are included in membership subscriptions,
therefore it is only the first inspection and any extraordinary inspections e.g. result of a complaint which will require payment separately.

# Application FAQs

#### Q. Why is there a non-returnable enrolment fee?

**A.** This fee is required as a contribution to the MLA toward the costs of the administration involved in the first line process of the application prior to the inspection being arranged.

#### Q. What about confidentiality?

**A.** Inspectors are not concerned with your customer details, only in your efficient record keeping and skill base. Their focus is not on your charges or competitive strategy, but rather on the standards and procedures of your business including quoting accurate prices. Some Inspectors have their own businesses and also have to be inspected, so they fully understand that much information is confidential – they will keep it that way. All Inspectors have signed the MLA's Confidentiality Agreement.

#### Q. How often are inspections carried out?

A. New applicants must be inspected as part of their application process and thereafter re-Inspections will take place as follows:-

- Second Inspection 2 years after First Inspection
- Third Inspection 3 years after Second Inspection
- Thereafter continuing at 3 year intervals.

If a complaint is made against an Approved Company, or if any changes occur to either the management or premises of an Approved Company additional Inspections may be carried out and maybe charged for. In interim years a declaration stating that no major changes (as above) have occurred within the company and copies of current documentation will be requested.

#### Q. What are the subscription fees for companies/branches?

**A.** (MAIN) £486.00 (BRANCH) £486.00 Please note that all regular inspections after the 1st are covered by the subscription fees.
