In September 2021, with support from our local Conservative MP Mark Pawsley, we raised concerns about the lack of government licensing in the locksmith industry. Despite numerous reports from homeowners who had fallen victim to fraudulent locksmiths, the government deemed licensing unnecessary, citing the effectiveness of the Master Locksmiths Association's accreditation scheme.

We remain active in raising awareness on this issue and recently featured on the BBC One, Sky News and local radio highlighting the problem of false advertisements on search engines.

The MLA Exam



Achieve a Level 4 certificate in General Locksmithing Skills and take the next step in your membership journey becoming a Qualified Master Locksmith.

Why take the MLA exam?

Upon passing the exam you will gain a Level 4 certificate in General Locksmithing Skills, which is **the highest level locksmithing qualification you can achieve in the UK**.

MLA personal members will be awarded QML status once they pass exam. To become an MLA Approved Company you must have a QML in place.

Who should take the exam?

The exam is ideal for anyone who is a working locksmith. We recommend at least 2 years working locksmith experience before attempting the exam.

All MLA registered members are required to pass the MLA exam within 4 years of membership.

How can I prepare for the exam?

We have a number of resources and courses available to help you prepare for the exam including our Exam Preparation Day. Our best advise is to have lots of practice.

What's involved?

The exam consists of four timed modules covering fitting, opening, cutting and a written paper; and can be taken with or without coaching.

You can sit one module at a time to make completing a qualification manageable and affordable.
